A motion was made by Commissioner Dunn and seconded by Commissioner Vicites to award Bid 21-02 for the removal and disposal of asbestos-containing materials and hazardous/regulated material associated with the building at the former Army Reserve Center located at 245 McClellandtown Road in Uniontown, Fayette County, Pennsylvania to Canfield Development in the amount of \$20,351.00.

Commissioner Dunn asked if there are receipts where the material is disposed of. Dave Witmer of Site Logiq said he is to be presented manifests for an approved dumping site. During the vote, Commissioner Lohr said he was abstaining because Ritenour is a distant cousin.

COVID-19 Hospitality Industry Recovery Program (CHIRP) Fayette County Implementation Proposal

This proposal is proprietary and remains the sole property of Fay-Penn Economic Development Council. It is intended for use ONLY by current Fayette County Commissioners. Any distribution of this proposal beyond that group must be requested in writing and be approved in writing by the Fay-Penn executive director prior to distribution. Once this proposal is approved by the Fayette County Commissioners it will by law be a public record.

Overview:

Pennsylvania passed Act 1 of 2021 (SB 109) that includes a provision — the COVID-19 Hospitality Industry Recovery Program, or "CHIRP" — to allocate grant funding among accommodation and food service/drinking place businesses in the Commonwealth. Fayette County will receive approximately \$1.464 million to distribute to county businesses whose North American Industrial Classification System (NAICS) code begins with 721 or 722 and who meet other eligibility criteria. Grants will be awarded to eligible applicants for the purpose of alleviating revenue losses and paying eligible operating expenses during the grant period of performance.

Statement of Work:

Fay-Penn will perform the following Statement of Work to implement CHIRP in Fayette County:

- (1) Adhere to requirements as outlined in Act 1 of 2021 (SB 109) and the Pennsylvania Department of Community & Economic Development (DCED) CHIRP Program Guidelines, with exceptions expressed in the Notable Caveats section of this document, and possibly other exceptions if additional "anomalies" are discovered during the performance of this program. Fay-Penn will discuss these anomalies as they are identified with the Fayette County Commissioners to arrive at resolutions.
- (2) Develop a grant application, rating system, approval process, and funding disbursement process with accompanying documents (e.g., application form, grant agreement, etc.). All public documents shall be made publicly available via (a) websites and social media sites maintained by Fay-Penn, (b) email as requested by businesses, and (3) other distribution channels as requested by businesses (e.g., fax, regular mail). Note: Other organizations will be permitted to link to the Fay-Penn website to promote this information upon request.



- (3) In conjunction with Fayette County, perform outreach to businesses in Fayette County focusing on for-profit businesses whose NAICS code begins with 721 or 722 to generate awareness about CHIRP, grant eligibility requirements, and how to apply for and be awarded grant funding. All requests for information about CHIRP will be directed to Fay-Penn to address or otherwise manage. Fay-Penn will disseminate information by publishing a webpage, generating e-blasts, posting to social media, performing direct outreach to Fayette County companies as much as practical, and using other channels that may become available.
- (4) Work with grant applicants as needed to complete, submit, and process applications, and validate applicant eligibility, revenue loss, and eligible expenses incurred.
- (5) Approve or disprove applications for grants. Approved grants will include award amounts in increments of \$5,000 up to a maximum of \$50,000. Fay-Penn will enter into grant agreements with grant awardees. Fayette County will act as the fiscal agent for the program and have sole responsibility for disbursing funds to grant awardees.
- (6) Maintain full and accurate program records for Fay-Penn's areas of responsibility outlined in this proposal.
- (7) Provide information to Fayette County regarding Fay-Penn's areas of responsibility outlined in this proposal to assist in Fayette County's program reporting, including providing audit review information if requested, to DCED.

Fees:

Fayette County will pay Fay-Penn \$300 for each grant application completed and reviewed regardless of the applicant's success in being awarded a grant. The total amount of grants awarded and fees charged cannot exceed the \$1.464 million awarded to Fayette County under CHIRP.

Notable Caveats:

(1) Act 1 of 2021 (SB 109) indicates that 2020 tax returns are required to substantiate revenue loss from 2019. 2020 tax returns may not be available until late in 2021. Fay-Penn is working to determine other suitable revenue loss substantiating documentation, e.g., quarterly or monthly sales tax returns.

- (2) Neither Act 1 of 2021 (SB 109) nor the DCED CHIRP Program Guidelines specify a mechanism for substantiating expenses incurred. Fay-Penn's grant agreement will include a self-certification statement by the applicant that the grant will be used for eligible expenses, but will also indicate that receipts for expenses will need to be submitted upon request.
- (3) Act 1 of 2021 (SB 109)'s concepts of a rolling application process and prioritization of applicants is mutually exclusive – they contradict each other. As Fay-Penn anticipates the vast majority of applications will be received within a short period after opening the program, Fay-Penn will implement a "phased rolling" approach as described in the Nominal Timeline section of this document. This approach will get needed funding into Fayette County businesses as quickly as possible.

Period of Performance:

Date of execution of a contract between Fay-Penn and Fayette County through August 31, 2021 or program completion if earlier.

Grant Allocation Guidelines:

- (1) Grants will be awarded with the intention of providing funding to the greatest number of applicants i.e., "spread the wealth."
- (2) Fay-Penn will develop a rating scale based on applicant gross receipts to determine equitable allocation of grant awards to the greatest extent practicable. (i.e., larger organizations may receive slightly larger grants. However, Fay-Penn anticipates that differences in awards will not be significant. Out of approximately 450 identified organizations in Fayette County that may be eligible for CHIRP, awarding grants to only one third of those equates to an average grant award of approximately \$10,000.)
- (3) It is anticipated that the vast majority, if not all, of the \$1.464 million allotted to Fayette County will be allocated during "Phase I."
