The following Bill of Costs is established by the Register of Wills of Fayette County, Pennsylvania, in pursuance of the Register of Wills' Act No. 18 of 1994

AND NOW, this 19th day of November 2004, the Orphans' Court Division Rule governing cost in the Register of Wills' office is amended to read as follows, effective March 1, 2005.

Effective immediately, Act 45 of 2025 increased the JCP/ATJ/CJEA/OAG fee by \$1.00 bringing the total fee from \$40.25 to \$41.25. The new fee begins on December 1, 2025.
