GENERAL REQUIREMENTS FOR ALL PROPOSALS

20-6 Yard Container with Side Door/Auto Lock & 70- 8 Yard Container with Slant Door/Auto Lock

The containers shall include a copy of the manufacturer's warranty. The successful bidder shall comply with the manufacturer's recommended pre-delivery service.

All components, parts and equipment shall be balanced to provide maximum performance.

Unless otherwise specified, the containers shall include all specified accessories, parts, equipment, and options made available for the indicated model.

The container(s) shall be complete with accessories, equipment, parts, and options properly installed and operative.

The container(s) shall be cleaned, lubricated, and serviced ready for immediate service.

The container(s) shall be free of dealer signs and emblems.

All optional equipment specified shall be factory installed by the manufacturer.

The container price shall include all miscellaneous fees including dealer preparation charges and delivery charges to Fayette County Bridge Department, 250 Duck Hollow Road, Uniontown PA 15401.

The bid contract will be awarded in total if Fayette County considers the award to be in its best interest. Award will be made to the lowest responsive and responsible bidder. GENERAL REQUIREMENTS (Continued)
