2009 or newer 40-yard Front Loader with full eject body

The vehicle(s) shall include a copy of the manufacturer's warranty or authorize a qualified dealer in the locality in which the vehicle is assigned to do whatever is required to comply with the manufacturer's warranty.

The successful bidder shall comply with the manufacturer's recommended pre-delivery service.

All components, parts and equipment shall be balanced to provide maximum performance.

Unless otherwise specified, the vehicle(s) shall include all specified accessories, parts, equipment, and options made available for the indicated model by the vehicle manufacturer. Specified items not available through the vehicle manufacturer shall conform to the best quality standards known to the particular industry.

The vehicle(s) shall be complete with accessories, equipment, parts, and options properly installed and operative.

The vehicle(s) shall be cleaned, lubricated, and serviced ready for immediate service.

The vehicle(s) shall be protected to 20 degrees Fahrenheit below zero with permanent type antifreeze.

The vehicle(s) shall include completely filled fuel tank or tanks.

The vehicle(s) shall conform to the requirements of the Pennsylvania Motor Vehicle Code.

GENERAL REQUIREMENTS (Continued)

Before submitting a bid, each bidder shall carefully examine the bid documents. No allowance will be made to any bidder because of lack of such examination or knowledge. The submission of a bid will be construed as conclusive evidence that the bidder has made such an examination.

No interpretation of the meaning of the specifications or other bid documents will be made available to any bidder orally.
