Violations of PFA and PSVI Orders

When a Defendant is arrested for a violation of a PFA or PSVI on an ICC charge, the following procedures must be followed:

- Obtain a copy of the PFA order from the Affiant to verify the terms and issuing Judge.
- Arraign the defendant and set bond.
- Check to determine if the underlying PFA or PSVI was issued by Judge Cordaro or Judge George.

If the PFA or PSVI was issued by Judge Cordaro or Judge George, schedule the ICC hearing before that **issuing Judge** according to the schedule of that issuing judge that is attached.

Schedule a hearing NO LESS than ten (10) days from the date of the preliminary arraignment. (Although the ICC hearing must be SCHEDULED within ten (10) days of arrest, the ICC hearing does not have to be HELD within ten (10) days.)

If the PFA or PSVI was issued by a judge **OTHER** than Judge Cordaro or Judge George, then schedule the ICC hearing for a date that is not less than ten (10) days from the arraignment, before the Judge who is assigned PFAs or PSVIs for that month, according to the attached schedule.
