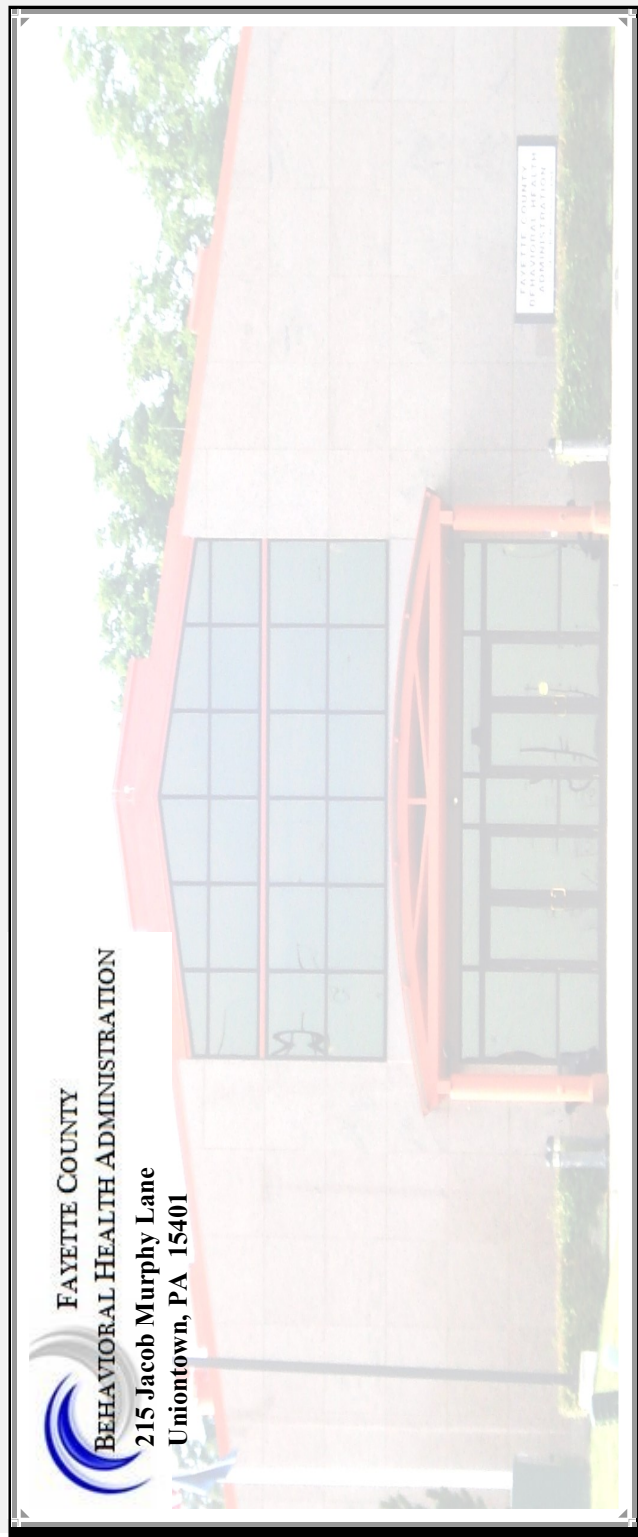

Intellectual Disabilities (ID)

If someone you love has been diagnosed with an Intellectual Disability, we can help you find the best programs and services to meet his or her individual needs. It is our responsibility to bring options to individuals and families through a vast network of local providers. This includes the development and implementation of quality programs in addition to monitoring funding for those eligible. We strive to ensure access to resources that provide for every person’s growth and meaningful participation in the community near family and friends.

To reach across all potential areas of need, **FCBHA plays an active role in the community** by sponsoring and participating in activities such as health fairs and wellness-oriented gatherings. Ongoing training of our staff and social workers within our system of care is regularly provided on new services and quality enhancement initiatives. In addition to this outreach, we conduct periodic reviews of quality initiatives, provider agencies, and supports coordination efforts for every program and individual in our network.

Who Is Eligible?

To be eligible for Intellectual Disability services, an individual must have either a diagnosed Intelligence Quotient (IQ) below 70 prior to becoming 22 years of age. If eligible, home and community-based services are recommended to assist in the acquisition, retention, or improvement of skills related to living and working in the community and to prevent institutionalization *(there may be a wait for some programs as they do reach capacity)*.

It is our goal to assure that individuals and their families are provided opportunities to participate in a variety of community-based services designed to meet their needs such as:

- ♥ Day and Residential Programs
- ♥ Independent Living
- ♥ Vocational Training
- ♥ Employment
- ♥ Life Sharing Opportunities

Every individual is assigned a Supports Coordinator ( case manager) who assists in locating and coordinating services and community supports . Services are provided at no cost to the individual. Once an individual has been found eligible, an Individual Supports Plan (ISP) is developed. Every ISP is unique to the strengths and needs of the individual.
