The containers shall include a copy of the manufacturer's warranty. The successful bidder shall comply with the manufacturer's recommended pre-delivery service.

All components, parts and equipment shall be balanced to provide maximum performance.

Unless otherwise specified, the containers shall include all specified accessories, parts, equipment, and options made available for the indicated model.

The container(s) shall be complete with accessories, equipment, parts, and options properly installed and operative.

The container(s) shall be cleaned, lubricated, and serviced ready for immediate service.

The container(s) shall be free of dealer signs and emblems.

All optional equipment specified shall be factory installed by the manufacturer.

The container price shall include all miscellaneous fees including dealer preparation charges and delivery charges to Fayette County Recycling Convenience Center, 105 Romeo Lane, Uniontown, PA 15401.

The bid contract will be awarded in total if Fayette County considers the award to be in its best interest. Award will be made to the lowest responsive and responsible bidder. Fayette County may also consider other factors, which it feels have bearing on the proposal. Fayette County reserves the right to reject any or all bids or parts thereof.

Fayette County reserves the right to make the determination as to the equivalency of any substitution from the specifications supplied in this proposal.

GENERAL REQUIREMENTS (Continued)

Before submitting a bid, each bidder shall carefully examine the bid documents. No allowance will be made to any bidder because of lack of such examination or knowledge. The submission of a bid will be construed as conclusive evidence that the bidder has made such an examination.
