All Zoning Permits-

A complete submission includes the zoning permit application, completely filled out & signed (original signature), accompanied by the fee. After review & approval, permits will be issued within 7-10 business days. Please write anywhere on the application if you (1) need a 911 address, (2) the mailing address where you want the permit sent, & (3) the exact verbiage needed if your permit needs state licensing. In the event that your permit is denied, you may appeal that decision to the Zoning Hearing Board (see ZHB action fees). Please note that any guidance and/or information you receive from office staff is based on past practice and is not a substitute for professional legal advice. Rezoning/Zoning Amendment Fee \$600.00

All rezoning/amendment actions must be in accordance with §1000-900 of the Zoning Ordinance. You (and/or your attorney) are required to attend a meeting in front of the Planning Commission and a hearing in front of the Board of Commissioners. A complete submission includes the rezoning petition, completely filled out & signed (original signature), accompanied by the fee. Please note that any guidance and/or information you receive from office staff is based on past practice and is not a substitute for professional legal advice. It is recommended to consult with an attorney regarding legal matters.

Subdivision & Land Development

A complete submission includes the appropriate application, completely filled out & signed (original signature), accompanied by the fee. Plans must be submitted with an application form which is located in Appendix No. 1 of the Subdivision & Land Development Ordinance.
